#### **HOW DO I EARN THE GRI?**

- 1. Be an active REALTOR® in good standing at your local association.
- 2. Complete the 15 required courses, in any order, within 3 years
- 3. Upon completion of all the courses, submit the GRI Application with a one-time application fee of \$50. NO annual dues to maintain the GRI.
