YOUR DUES EXPLAINED





SMDRA dues are based on a fiscal year of October 1 through September 30, and include CAR and NAR dues. Dues can be paid online through your SMDRA Member portal.

The total amount is due every year during our renewal process, usually during the months of August and September. If you are transferring from another Association or applying to become a new member, contact a SMDRA staff member to assist you with the calculation of your dues and submit verification of your NAR Code of Ethics training.

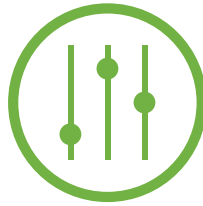

BUYER/SELLER MEDIATION & ARBITRATION

A Program Designed to Assist in Real Estate Transaction Disputes

The SMDRA Real Estate Program has been designed to implement the mediation clause presently in Colorado real estate contracts to provide a solution for disputes between buyer and sellers. This program is not intended to replace the REALTOR® Professional Standards Program, which addresses disputes between REALTORS® or REALTORS® and their clients or customers, but is an option for those disputes which are not covered under mandatory or voluntary arbitration. What situations are appropriate for this buyer/seller dispute mediation program? Mediation can be helpful in resolving almost any dispute arising out of a real estate transaction, including:

- Disputes over earnest money deposits
- Condition of property and repair conflicts



ETHICS & ARBITRATION

A Program Designed to Assist in Real Estate Ethics Disputes

REALTORS® are different from other real estate licensees in that they voluntarily pledge to abide by a strict code of professional conduct above and beyond the licensing laws of the state. This conduct is outlined in the National Association of REALTORS® Code of Ethics. If you feel like any part of the Code has been violated by a REALTOR®, you are entitled to file a complaint. The REALTORS® Code of Ethics is comprised of seventeen Articles. The Articles are explained through accompanying Standards of Practice. Follow the QR Code of complete details and filing information.

Protect Your Business!

The REALTORS® Legal Hotline is a service which provides members of the Colorado Association of REALTORS® with direct access to a qualified real estate attorney who can offer information on real estate law and related matters. The Hotline provides legal information, not legal representation. A call to a real estate lawyer costs an average of \$250 per hour. Think about it, JUST ONE hotline call, you can offset your CAR dues.

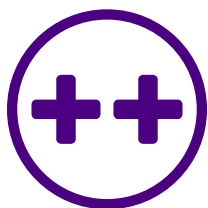

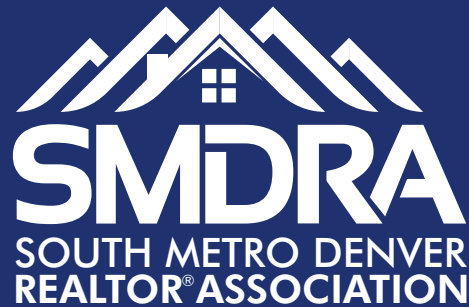
